**Camp Session is July 24 – July 28, 2017 with classes from 12:30pm – 5:30pm on Monday - Friday.**

This year's production is *Peter and Wendy*. There will be a live performance on Friday July 28, 2017 at 6pm as part of the camp. Family and friends are invited to attend.

**The cost is \$245 for the camp session. Payment may be made in two installments: Early bird registration \$235 if registered by May 1<sup>st</sup> payment in full is due with early bird registration , if paying in instalments First installment is \$125 and is due by May 5th, 2017. Second payment is \$120 and is due by July 1, 2016. First payment of \$125 is a non-refundable deposit. CAMP CLASS SIZE IS LIMITED. NO AUDITION REQUIRED.** Students must be between the ages of 7-16 by July 15, 2017

Please send this application and a check (or call 409.765.1894 for credit card payment) with the **non-refundable registration fee of \$125.00** made out to **The Grand 1894 Opera House**.

**PLEASE NOTE: As this camp is a week-long residency with a full performance following, campers must attend all scheduled sessions and commit to Friday evening performance at conclusion of camp.**

This residency is set up as a theatre day camp. When your child's character is not in rehearsal they will be engaged in different activities that are related to the book *Peter and Wendy*. Please see below for a sample daily schedule:
